

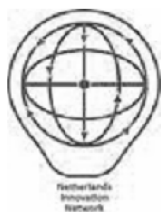

They are using a lot (many patients and many patients are somewhat overweight), and the regular channels in Europe cannot supply enough.

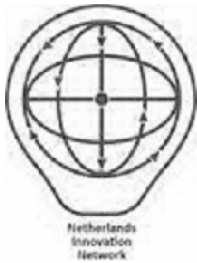

Email from (10)(1c) to CIBG Health and Youth Care Inspectorate in Netherlands

Dear Dr. (10)(2e) (10)(2e),

Thank you for considering our product for use in The Netherlands.

Thanks for your support, we submitted the Letter of No Objection (LONO) issued by CIBG Health and Youth Care Inspectorate to receive export permit of propofol injection.

The person in charge (Mrs. (10)(2e)) of Narcotics Policy Division in Ministry of Food and Drug safety noticed that the issuing date of LONO is April 8, 2019.

We need this corrected to April 8, 2020. Everything else is OK and Mrs. (10)(2e) understands that this is just a typo.

Meanwhile, there is one more issue that we need your help.

Because our product is not registered in The Netherlands, Mrs. (10)(2e) says that there has to be a notice coming through an official route for urgent orders like this.

That is, CIBG or the government of The Netherlands itself has to notice our Narcotics Policy Division directly or via The Embassy of The Netherlands in Korea.

A purchase order from a private company like OFICHEM or FARMASERVICE HZ is not enough according to Mrs. (10)(2e). She just wants make sure everything is clarified.

Sorry for the inconvenience but please send a letter to Mrs. (10)(2e) explaining that you need our products.

Also please contact relevant person in the Embassy of The Netherlands and tell him/her to contact Mrs. (10)(2e) and explain that The Netherlands needs our products as soon as possible.

With your help, everything will be clear and we will be able to get export permit in a short time.
