As I mentioned in my LinkedIn message I work 5.1.2.e at the Interior Department of the Dutch Government.

During the COVID-19-crisis we have been in contact with several tech companies about their disinformation policy and other measures taken in the past month. These regular contacts have allowed both us and these companies to stay up to date on developments and reach out to each other when necessary.

We have not yet been in contact with TikTok, also not about the COVID-19-crisis and the effect it has on the spread of (dis-)information online. We would like to open up the lines of communication and set up an introductory call between TikTok and the Dutch Government. Our idea is to get to know a bit more about TikTok's views on disinformation and whether policy has been changed in light of COVID-19. We would also like to explain our point of view on disinformation and the role that tech companies and the government should, and should not, play in our opinion. Would you, or someone else from TikTok, be willing to meet (virtually of course) with us to discuss this sometime soon?
