Obviously at lot has been happening these last couple of weeks regarding COVID-19. Hopefully you and your loved ones are all still in good health.

Also on the government's side we have been quite busy with mis- and disinformation regarding COVID-19. We discussed this in our inter-ministerial working group, and there were quite a lot of questions also on the social media side of things.

Therefore I figured it might be a good idea to do a mutual video call, if you are also up to that.

I have been in contact with you regarding you current policies related to COVID. I have relayed this also to my colleagues so they are also up to date.

However, the questions they had are more on the execution and coordination side of these policies. For example on the AI that detects the misinfo, or whether you can share information about what you removed (numbers, but also what kind of content, topics, possible bots or coordinated activity etc.). Also, do your companies work together by for example sharing fact-check/removal information?

On our side we have been working on a new policy letter related to misleading information about COVID-19. We aim to send it to parliament some time next week, so we'll probably also be able to share what we as a government are doing.

So my question is if you have time for a video call sometime next Thursday morning. On our side it will probably include people from multiple ministries who all are involved in our disinformation work.

Please let me know if you are interested in joining such a video call.

The system we will be using will probably be Webex, which is what we now use at the ministries. It should be accessible for external parties as well.

I'll send out an agenda/topic list beforehand so everyone can properly prepare, so also let me know if there are things you wish to know from us!
