Our [May 2020 Coordinated Inauthentic Behavior Report](#) is now available. This month, we have removed two networks of accounts, Pages and Groups. One of them - from Tunisia - focused on countries across Francophone Africa, and the other one targeted domestic audiences in the Kurdistan region of Iraq. We have shared information about our findings with law enforcement, policymakers and industry partners.

We published the fifth edition of our [Community Standards Enforcement Report](#), providing metrics on how well we enforced our policies from October 2019 through March 2020. In the future, we'll be sharing the Community Standards Enforcement Reports quarterly, so our next report will be released in August.
