Dear 10.2.e,

I am fine (under the circumstances). Hope you are too.

Our government has approved "phase 2" (14th April to 31st May), "phase 3" (1st June to 31st August) and "phase 4" (1st September to 31st October). No extra funds have been granted, so the total of 1,5 billion DKK is the amount that the travel organizers can borrow from the Danish Travel Guarantee Fund for corona-cancelled package tours up until 31st October 2020. The package tour must have been cancelled according to the advice of the Danish Foreign Ministry. The travel organizers can borrow the actual costs related to the package tours (the amount they have not succeeded in getting back from the suppliers). They must pay back the loan within a 6 year period (according to EU-regulations).

Dear 10.2.e

How are you? I hope you are doing well.

In the Netherlands the guarantee fund SGR and the Government are looking into the possibility to create a solution like in Denmark.

Would it be possible to talk with you on Monday about the following questions we have:

- According to the document attached (which we received from our contacts in Brussels) the Government in Denmark has granted the Danish Guarantee Fund with a loan which consists for an amount of € 154 million in coverage for refunds for cancelled travel sums and € 47 million additional liquidity.
- How is the amount of € 154 million calculated (for cancellations until the end of April)? What is happening with the cancellations after April? Do you receive more funding?
- Do consumers receive a refund without bankruptcy of the involved tour operator?
- Do consumers directly receive a refund or via the tour operator? How does this work? On a claim basis?
- Which conditions are applicable for tour operators and consumers?
- How will tour operators repay the guarantee fund?
- Is this a fee, how is the fee calculated?
- Is this a percentage of turnover or per booking?
- The EU considers that the Danish Guarantee Fund is a 'private undertaking'. It has been my understanding that the fund is a state fund, run by your Government. Is this correct?
- Which interest rate is applicable and how long does it take to repay the Danish Government?
- If the fund repays directly to the consumer how do you take the airline voucher received by the tour operator into consideration when the cancelled package also consists of an airline ticket?
- Is a standalone airline voucher also repaid to the consumer by the fund?

If you have possibilities tomorrow to speak with us for 30 minutes, I will provide you with an invitation for a Microsoft TEAMS meeting with me and 10.2.e (board member). Your response and input on this matter will be highly appreciated!
