Thank you 10.2.e for your very helpfull response.

The Government official that is discussing the concept of the voucherbank with us has the following additional questions:

The travel organizers can borrow the actual costs related to the package tours (the amount they have not succeeded in getting back from the suppliers) -> How is this audited/checked? The state authorized/registered accountant of the travel organizer signs a declaration (ISA 800 or a declaration we call "erklæring om aftalte

arbejdshandler” (I don’t know the English term – maybe: “declaration of agreed working actions?”)).

- Do you check the current creditability or does every member of the Fund receive an amount on request based on ‘actual costs’? **Every member of the Fund received an amount on request based on “actual costs”.**
- How much of the 1,5 billion DKK has been used? **I think about 50%, but I am not sure.**

It would be very helpfull to receive your response again on these questions.

We have a meeting on Thursday 24 September at 10:00 am with our Government to discuss this topic, hopefully I have received your valuable input before.

Dear 10.2.e,

I am fine (under the circumstances). Hope you are too.

Our government has approved “phase 2” (14<sup>th</sup> April to 31<sup>st</sup> May), “phase 3” (1<sup>st</sup> June to 31<sup>st</sup> August) and “phase 4” (1<sup>st</sup> September to 31<sup>st</sup> October). No extra funds have been granted, so the total of 1,5 billion DKK is the amount that the travel organizers can borrow from the Danish Travel Guarantee Fund for corona-cancelled package tours up until 31<sup>st</sup> October 2020. The package tour must have been cancelled according to the advice of the Danish Foreign Ministry. The travel organizers can borrow the actual costs related to the package tours (the amount they have not succeeded in getting back from the suppliers). They must pay back the loan within a 6 year period (according to EU-regulations).

Hope you are doing well. We are currently discussing a voucherbank plan with our government. We already received support for € 150 mio finance in case of large bankruptcies. We are looking into the possibilities to finance the vouchers in the Netherlands, like you did in Denmark.

Our government is asking me how Denmark handled phase 2 arrangements and probably also phase 3 (after May 2020). Could you provide me with an update on this topic which I can use for information purposes with our Minister of Economic Affairs?
