Airlines are currently facing an unprecedented crisis in COVID-19. COVID-19 is challenging the economic viability of the aviation sector as never before in history. 10.2.g
[redacted]. Furthermore it is expected to last many months.

Airlines are facing a cash flow crunch due to the fall in demand and revenue. Despite operating viable business models, many companies are putting a significant amount of staff on temporary leave due to lack of liquidity over the next months.

Any measures which improve the liquidity of airlines in the short run would be a benefit to connectivity across Europe, enabling the continuation of rescue flights and essential transport links. It will also help ensure a full return to mobility once the current outbreak has finished.

We believe passengers should be repatriated where they have been stranded as a result of the COVID-19 outbreak. easyJet are continuing to do this. 10.2.g
