Following our discussions over the past weeks and my Minister's strong preference to work with your organization, I would like to ask you if you could provide further information on possibilities to establish dedicated shelters/reception facilities for UAM on the Greek mainland. As discussed, the Netherlands government is willing to finance up to 48 places in one or - based on your earlier proposal for UAM shelters on the islands - several locations (4 x 12?).

- Do you already have a specific location in mind?

- **There are multiple empty buildings in Athens area that we find suitable for the shelters.**

- Would it involve one facility of 48 or several smaller units?

we aim for either 4 shelters of 12 or 2 shelters of 24 places

- With which local partners would you preferably co-operate ?

Our preferred partner is the Homeproject.org (they already have 11 existing shelters, being the largest in Greece) and we are about to set up an MOU with them

- What kind of activities would you and your partners provide for the uam?

See short presentation

- How much time would you need to acquire an adequate location and become operational?

We are ready to start as soon as an agreement has been established with the Dutch government. timeframe of opening a shelter depends on release of funds and the registration of our NGO in the necessary greek registers

- Could you please provide an estimate of the costs? If possible, please differ between acquisition of the location, daily operations, etc.

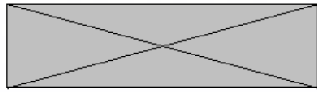
