Please see the attached documentation for the specific information regarding this violation.

10.2.a will collect and analyze samples of future shipments from Establishment 82EG for chemical residues at an intensified frequency. This intensified frequency will remain in effect until 10.2.4 finds at least 15 lots and 15 times the weight of the failed lot to be acceptable according to 10.2.a regulations.

Within 30 days of the date of this letter, please provide a report of investigation regarding this violation. 10.2.a requests that the report reflect the analysis of the investigation by the Ministry of Agriculture, Nature and Food Quality subject matter experts at the appropriate management level and addresses the following:

- Identify the source and cause of the violative 2-Amino-Flubendazole findings;
- Identify any corrective actions and preventive measures developed by the establishment to address the source(s) and cause(s) of these findings;
- Provide details of verification activities conducted by the Ministry to ensure the establishment's corrective actions and preventive measures are adequate to prevent recurrence of this residue finding;
