Subject: update nouvelle corona virus from department of Public Health Bonaire

To: all General practitioners, medical specialists en medical physicians on Bonaire

As you are aware, since the beginning of this month there have been ongoing reports in the media about de novel 2019-nCoV infections which Chinese authorities have identified in Wuhan City, China. Cases with travel history to Wuhan have been detected in other areas of China, such as Beijing and Guangdong. Hong Kong, Macau, Taiwan, Thailand, Japan, South Korea, the United States, Singapore and Vietnam have also reported cases.

The change that the corona virus comes to Bonaire is estimated to be very low at this moment. It is however always possible that patients come to you with questions about this new corona virus. In the case you do see travelers who have recently been to China and/or patients who present with an acute respiratory illness, it is important to ask the exact location the patient has been, when he has been there, and whether fish or live animal markets have been visited and whether there has been contact with patients with 2019-nCoV infection. In the case of a suspected case we ask you to please notify the department of Public Health.

Attached you will find the latest update from CARPHA (Caribbean Public Health Agency) with the latest case definitions of 2019nCoV from the WHO.

Also we would like to inform you that the department of Public Health has published a press release this afternoon (see attachment).

We are following the developments closely and will keep you posted.
