E) ORDERS OF THE FEDERAL MINISTRY OF HEALTH WITH THE AIM OF PREVENTING THE INTRODUCTION OR SPREAD OF INFECTIONS BY SARS-COV-2 I.

THE PILOT RESPONSIBLE FOR AN AIRCRAFT ARRIVING FROM THE PEOPLE'S REPUBLIC OF CHINA (INCLUDING THE HONG KONG AND MACAU SPECIAL ADMINISTRATIVE REGIONS), INCLUDING AFTER A TECHNICAL STOP, MUST SUBMIT THE HEALTH PART OF THE AIRCRAFT GENERAL DECLARATION UPON LANDING AT THE FIRST AIRPORT IN THE TERRITORY OF THE FEDERAL REPUBLIC OF GERMANY.

II.

ON ALL AIRCRAFT ARRIVING IN THE FEDERAL REPUBLIC OF GERMANY FROM THE PEOPLE'S REPUBLIC OF CHINA (INCLUDING THE HONG KONG AND MACAU SPECIAL ADMINISTRATIVE REGIONS), INCLUDING AFTER A TECHNICAL STOP, CREWS MUST PROVIDE INFORMATION LEAFLETS OF THE GERMAN FEDERAL MINISTRY OF HEALTH ABOUT SARS-COV-2 TO ALL PASSENGERS DURING FLIGHT.

ALL TRAVELLERS, CREW MEMBERS AND OPERATING PERSONNEL ARRIVING IN THE FEDERAL REPUBLIC OF GERMANY BY AIRCRAFT THAT HAVE DEPARTED FROM THE PEOPLE'S REPUBLIC OF CHINA (INCLUDING THE HONG KONG AND MACAU SPECIAL ADMINISTRATIVE REGIONS), INCLUDING AFTER A TECHNICAL STOP, MUST FILL IN THE PUBLIC HEALTH PASSENGER LOCATOR FORM (PLF) AND SELF-DECLARATION.

IV.

THE PLF AND SELF-DECLARATION MUST BE COLLECTED BY THE CREW AND CHECKED. IF A PASSENGER ANSWERS AT LEAST ONE QUESTION OF THE SELF-DECLARATION WITH 'YES' OR IF A PASSENGER REFUSES TO COMPLETE THE SELF-DECLARATION, THE DESTINATION AIRPORT MUST BE INFORMED ACCORDING TO ICAO DOC4444 (PANS ATM, NOTIFICATION OF SUSPECTED COMMUNICABLE DISEASES, OR OTHER PUBLIC HEALTH RISK, ON BOARD AN AIRCRAFT).

PLF AND SELF-DECLARATION MUST BE HANDED OVER TO THE PUBLIC HEALTH AUTHORITIES AT THE DESTINATION AIRPORT.

V.

AIR CARRIERS MUST KEEP THE DATA AVAILABLE TO THEM FOR FLIGHTS FROM THE PEOPLE'S REPUBLIC OF CHINA (INCLUDING THE HONG KONG AND MACAU SPECIAL ADMINISTRATIVE REGIONS) TO THE FEDERAL REPUBLIC OF GERMANY FOR UP TO 30 DAYS. THIS APPLIES, IN PARTICULAR, TO ELECTRONICALLY STORED DATA FOR IDENTIFICATION AND CONTACT DETAILS OF TRAVELLERS AS WELL AS TO SEATING PLANS.
