Model for progressing cooperation on the AstraZeneca contract How the others can join!

Italy, France, Germany and The Netherlands (The Inclusive Vaccine Alliance) have closed an agreement with AstraZeneca (AZ) on the development of a Covid-19 Vaccine and the possible purchase of 300-400 million doses of this vaccine at Cost of Goods (COGs). This contract opens the door for other EU-member states to join the agreement, under the same conditions as the four countries of the Alliance. It would be the preferable option, if this contract could be joined by the European Commission, in order for other EU countries to smoothly join in. However, at this moment this model does not seem likely and we are preparing the working methods to arrange good and swift participation by EU member states.

The countries of the Alliance have agreed to a model under which other EU countries can join the deal and which takes care of the financial, legal and administrative affairs of this cooperation.

In this respect the Inclusive Vaccine Alliance proposes the following:
 Other EU member states can join the AZ deal as follows:
 An EU member state joins the agreement under the exact same conditions as the countries of the Alliance. In that case these countries become full

partners and will be entitled to a fair share of the possible vaccine (according to population size), at the same price as the members of the Alliance. Further details can and will of course be shared with interested member states.

To qualify, the country needs to commit on a buy in, before the 1st of July 2020 and will have to bear its proportionate share of the upfront payment costs, already paid for by the member states of the Alliance.

If member states decide to apply for an opt-in past the stated date, but before ultimately the 1st of September, this country will still be able to join in under the same terms but will not share in the first batch of available vaccines at the end of 2020. For this group first delivery will start in Q1 2021.

In any case the total costs involved will be equally shared among all participants, as the available volume of vaccines is distributed by population size.

The countries of the Alliance will together establish a focal point to deal with all matters stemming from the participation of the EU-member states that wish to join in. [e-mail address/contact information]
