Dear Colleagues,

In an extraordinary meeting of the ECDC Advisory Forum on 2nd March 2020, it was agreed that EU/EEA Member States would move toward a system of self-declaration of areas with ongoing community transmission of COVID-19 so as to allow other Members States to adapt their travel-based testing approaches in the ongoing outbreak. ECDC's proposal is that Member States report the areas which they classify as having ongoing community transmission at NUTS-level, as described in the attached instructions and using the attached macro-enabled excel file. ECDC would collate and share these responses, which MS would update as frequently as the situation changes in their country.

Please provide feedback, if any, on this proposal by close of business Tuesday 10th March.
