Despite the summer break for many of us, August has been a busy month! Please read carefully the following bullet points and feel free to get in touch and share your progress regarding the development of COVID vaccines interim recommendations.

COVID:

HPV :

- (10)(2a) The Joint Committee on Vaccination and Immunisation's (JCVI) statement on delivery of the human papillomavirus (HPV) programme in light of school closures associated with coronavirus (COVID-19), available [here](#).

WHO:

- The Robert Koch Institute, World Health Organization, and London School of Hygiene and Tropical Medicine are developing an online registry of **systematic reviews** in the vaccination field and an accompanying e-learning course. To help us set up the registry and e-learning course and ensure they meet your needs, a short survey has been developed: <https://befragungen.rki.de/SE/1/SYSVAC/>. **We would appreciate if you could fill it out by August, 31st.**
- **Two reports to support the use of models in planning the COVID response:** technical experts on infectious disease modelling, COVID-19 modellers, and decision-makers from different geographies and affiliations worked together under the auspices of the COVID-19 Multi-Model Comparison Collaboration (CMCC) to discuss the policy relevance, robustness, and usefulness of current models for Low and Middle Income Countries (LMICs), as well as to inform future modelling efforts. This collaboration has led to today's release of two global public goods: a **Guidance on Use of Modelling for Policy Responses to Covid-19**, prepared by the CMCC's Policy Group through engaging decision-makers across the world and within the CMCC and the **Model Fitness-for-Purpose Assessment Report** prepared by the CMCC's Technical Group. Both reports are attached.
- Please find attached the latest version of the catch-up guidance document **Leave No One Behind: Guidance for planning and implementing catch-up vaccination** – *this is a foundational document that covers catch-up vaccination as an essential component of a strong immunization programme, outlining the basic system enablers required to allow and promote catch-up through routine immunization.*
