ZonMw opened the second COVID-19 call last Sunday. Max budget is (10)(1c) for 24 months. The deadline is 14 May, 2pm. It is a two-stage procedure.

- The core questionnaire is finalised

- AMIGO is not done yet with the DPIA - we are trying to answer questions from our FG
- EPIC is also working on clearance (nWMO/DMP/DPIA)
