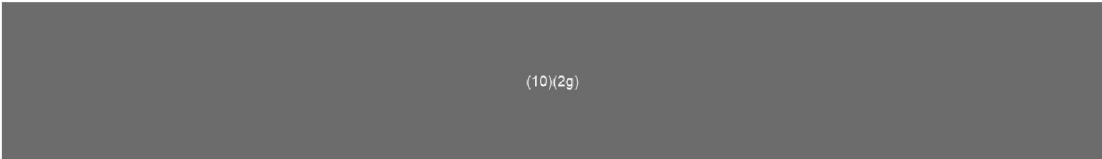

Biological agents, which are micro-organisms that may be able to provoke any inf toxicity, can be classified into four risk categories, according to their level or risk Article 2 of Directive 2000/54/EC):

1	group 1 biological agent means one that is unlikely to cause human disease
2	group 2 biological agent means one that can cause human disease and mig to workers; it is unlikely to spread to the community; there is usually effect or treatment available
3	group 3 biological agent means one that can cause severe human disease serious hazard to workers; it may present a risk of spreading to the commun usually effective prophylaxis or treatment available
4	group 4 biological agent means one that causes severe human disease a hazard to workers; it may present a high risk of spreading to the commr usually no effective prophylaxis or treatment available

Also many thanks to those of you who provided us with feedback on the draft minutes that were circulated after the meeting.

With this email we would also like to inform you of the next steps. The draft measures prepared (draft Commission Directive updating Annex III to Directive 2000/54/EC) are currently being reviewed by the other Commission services, and will be submitted on 8 May the latest to the Technical Progress Committee (TPC), which is composed of representatives of the Member States. The draft Commission Directive will be discussed in a virtual meeting of that committee, which will be held on 14 May 2020 and during which the MS representatives will vote on the measures put forward. If the vote is positive, the Commission will adopt the measures and they will immediately be implemented. The Commission communicates them without delay to the European Parliament and the Council, who will have one month to oppose the measures on a limited number of grounds.
