Dear Colleagues

The Netherlands is developing a Covid-19 dashboard to strengthen the view of and insight into the spread of the corona virus. We would like to know how other countries are working on picking up signs of the virus's revival and then being able to contain it quickly and effectively. To learn from others we would like to get the following information from your country:

1) What is your country doing in terms of a Covid-19 dashboard. How does it look? Which indicators / signal values are used?

NL uses the following five main indicators

- IC capacity
- Number of hospital admissions
- Numbers of (positive) tests
- R value (the average number of people that are infected by one infected person)
- Number of infectious persons

2) Do you think that your country is willing to cooperate with the Netherlands on developing such a Covid-19 dashboard?

The design phase is, for example, about the nature of the indicators and comparability. And why which signal values are used.

If there are opportunities for cooperation, it would be a nice goal if countries use the same values.

When it comes to what is done administratively with the Dashboard, it is also interesting to exchange the more steering-like issues.

And if signal values go in a certain direction, what and how will this be continued in an administrative sense?
