Like our French colleagues, the Netherlands would like to congratulate the Commission, and you and your team in particular, for the successful conclusion of an advanced purchase agreement with AstraZeneca. You and your team have proven that the EU Vaccine Strategy is a fruitful approach by finalizing the deal (which was initiated by the Inclusive Vaccine Alliance) into a definitive contract for Europe.

The Netherlands is willing to participate in the agreement and order a number of doses proportional to the share of its population in the European Union. For the Netherlands, the pro rata is approximately [redacted] 5.1.2b doses. It is the intention of the Netherlands government to offer this vaccination to our whole population according to priority criteria, whatever their place of residence in the Kingdom of the Netherlands, including our overseas countries and territories.

Nevertheless, to support our European partners in being able to vaccinate their population likewise, the Netherlands authorities has agreed, alongside other Member States, to reduce our share, if necessary, by 3 % (i.e. around [redacted] 5.1.2b doses) in order to allow for countries of the EEA and Switzerland to be covered out of the EU's [redacted] 5.1.2b doses.
