With lots of thanks for our conversation on this excellent draft, you may find enclosed, the draft with our TCs, including a new page « annex », as discussed.

We have discussed already the few points we had, in particular :

- 5.1.2a
- the need to show openness to EU institutions, given their will to take the lead as well (as I told you, a note to the Antici, attached FYI, is clear on their intention to ask for a negotiation mandate soon)

On the second point made above, we finally introduced a softer wording than the one I suggested, around « best efforts to associate », which might be more agreeable to our partners.

Since our discussion, we have also inserted a mention of « the most vulnerable ones » within our statement of purpose, because the product we want in the end is a product which does work with them (the elderly etc.) and not just the general population. Hope that is fine with you as well.
