Goal: Over its 5-year mandate, GHSA, working with relevant partners, will actively contribute to national, regional, and global efforts to support countries in evaluation, planning, resource mobilization, and implementation of activities that build health security capacity.

Target: By 2024, more than 100 countries that have completed an evaluation of health security capacity will have undergone planning and resource mobilization to address gaps, and will be in the process of implementing activities to achieve impact. These countries will strengthen their capacities and demonstrate improvements in at least five technical areas to a level of 'Demonstrated Capacity' or comparable level, as measured by relevant health security assessments, such as those conducted within the ((10)(2a))

1. Welcome and adoption of the agenda + Welcoming (10)(2a)

Since we haven't had a formal meeting since last November, we decided to have this Steering Group meeting divided over 4 days. We hope this allows us to keep everybody sharp for these short meetings, and concentrate discussions.

Before we start, just a short reminder of this meetings etiquette. If you'd like to speak, there is the opportunity to raise your hand through the webex app. We will then give you the floor to speak, in the order in which we receive this request. If you are experiencing any technical difficulties, please let us know either through the chat, through messaging the phone number provided in the agenda, or if those two options do not work, by email. As always, we will try to focus on the discussions on concrete actionable outcomes. We plan to assign tasks similarly to the Action List we made after the Brussels meeting. If you have a suggestion for a concrete activity GHSA should undertake, please also state who you think should take up this task.

With that said, I'd like to start us off on the agenda. First of all, let me welcome a new Steering Group member; last year, (10)(2a) responded to the call for new Steering Group members. We are very happy to welcome a new, motivated member in our midst, and we look forward to a fruitful cooperation over the coming 2 years. Probably, this is not the way you would have imagined your first Steering Group meeting, but hopefully, we

Concluding; Thank you all for your comments. Can we conclude that the Secretariat will keep an action list, also after this meeting, to ensure good

follow-up to our decisions? I hear no objections, thank you, and then we can move on to our next agenda item.
