Germany said today that we should look at the tourism question, from a perspective of mutual trust.

I would appreciate it if we could have a phone call later this week, on the Danish perspective on this.

Because it would be difficult if countries like Denmark, Germany and The Netherlands would give their citizens different advises this summer holiday.
