As we discussed with you and (10)(2e) we agreed that it would be good to

- 1) First discuss with/ask opinions from your WP6 partners about major changes in WP6 plans. It would be important to engage and involve all WP6 partners in WP6 planning.
 - Especially in 6.2.2 it would be good to check whether your WP6 partners have some national needs or information gaps which need to be filled, and/or whether some countries are already performing similar actions
 - Chemicals: call also WP9 /PHE (Task 6.2.4 etc)
- 2) Contact also DG SANTE and ECDC
 - Especially concerning in 6.2.1 – on COVID-19 testing strategies, it would be important to hear DG SANTE and ECDC views on these plans
- 3) Then the plans can be presented to the SC. After SC approval, these changed can be sent to Chafea and DG SANTE for approval, and then included in the next amendment.

We know that this is some extra work but bigger changes need to be approved by the SC before implementing them in action.

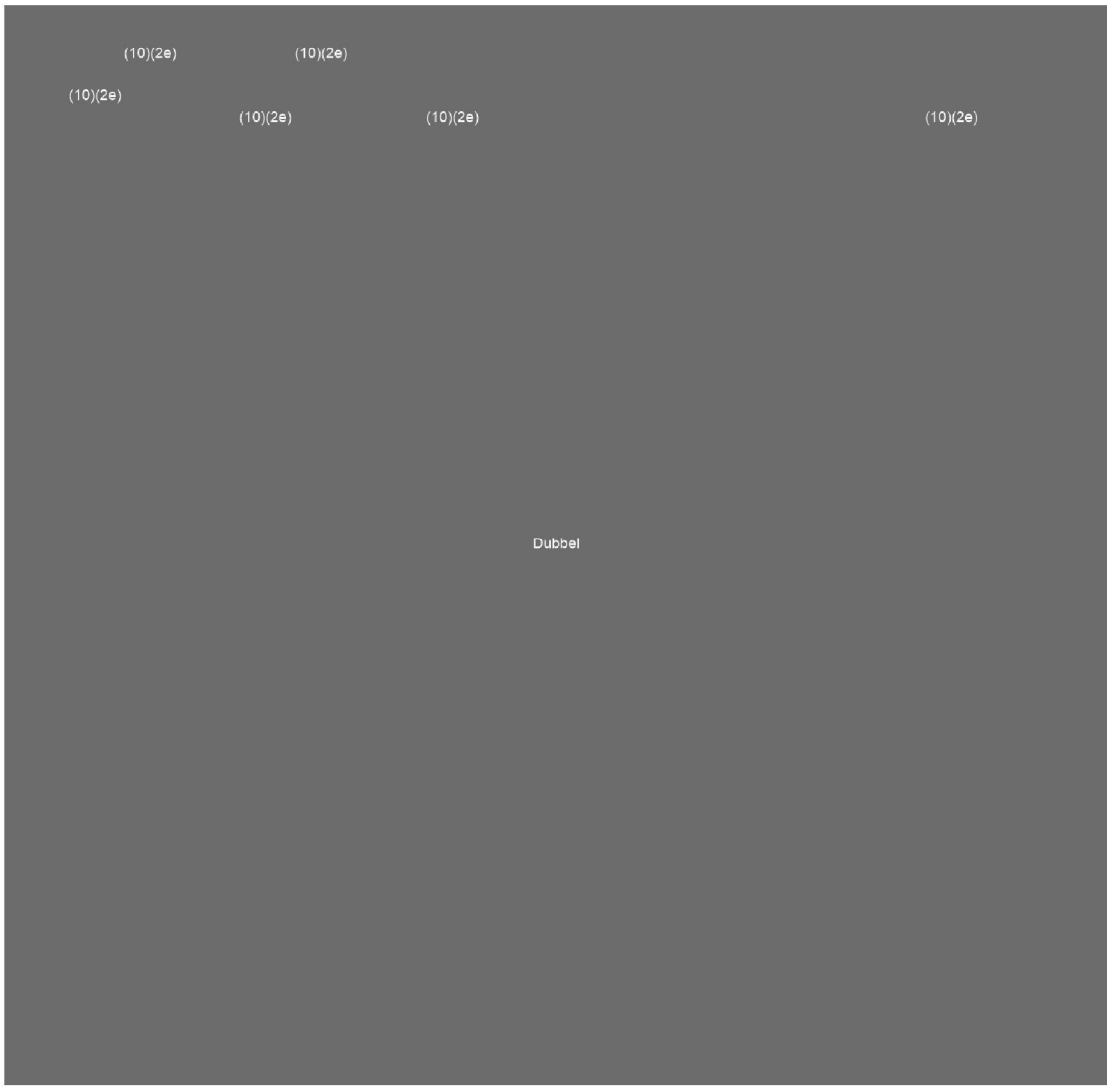

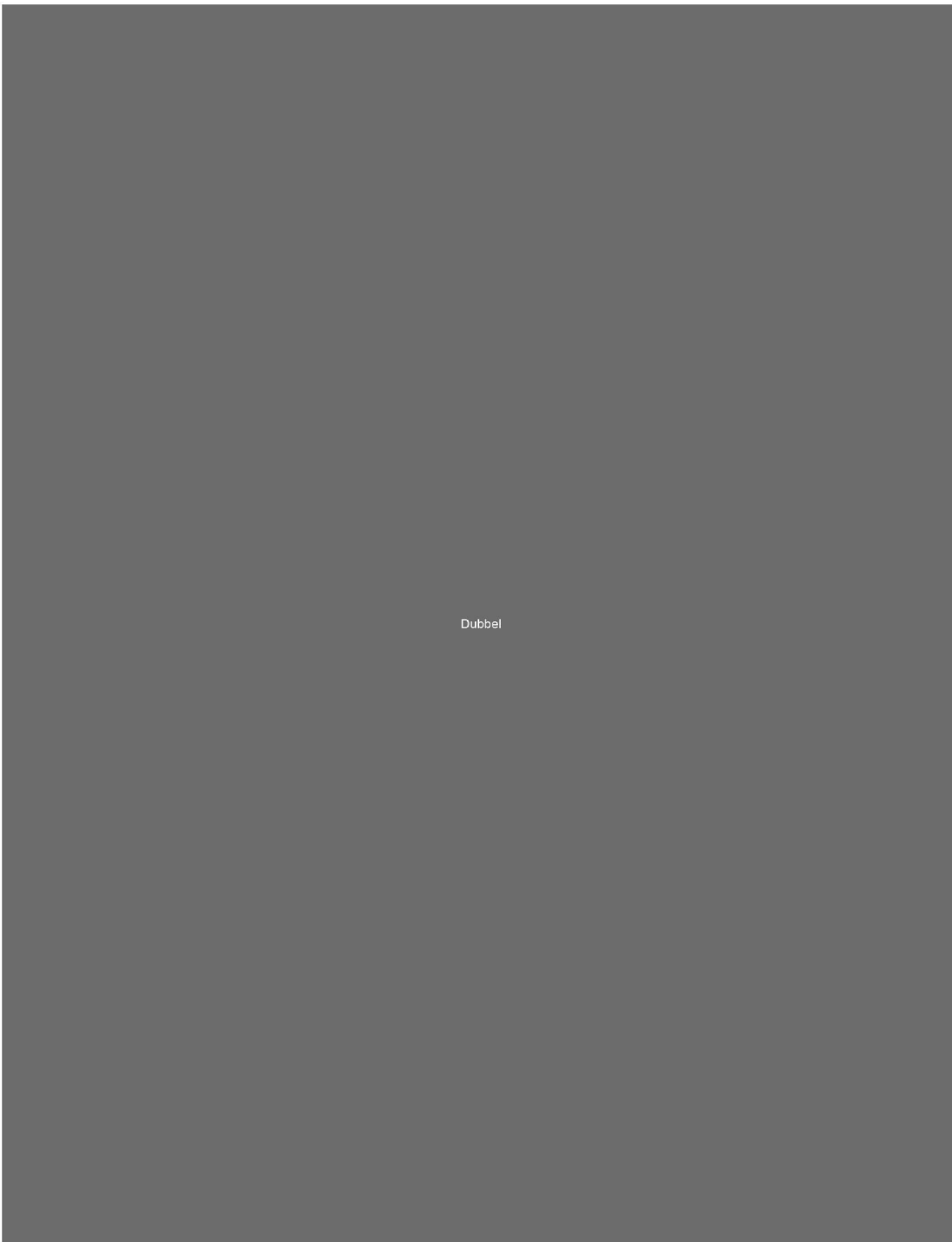

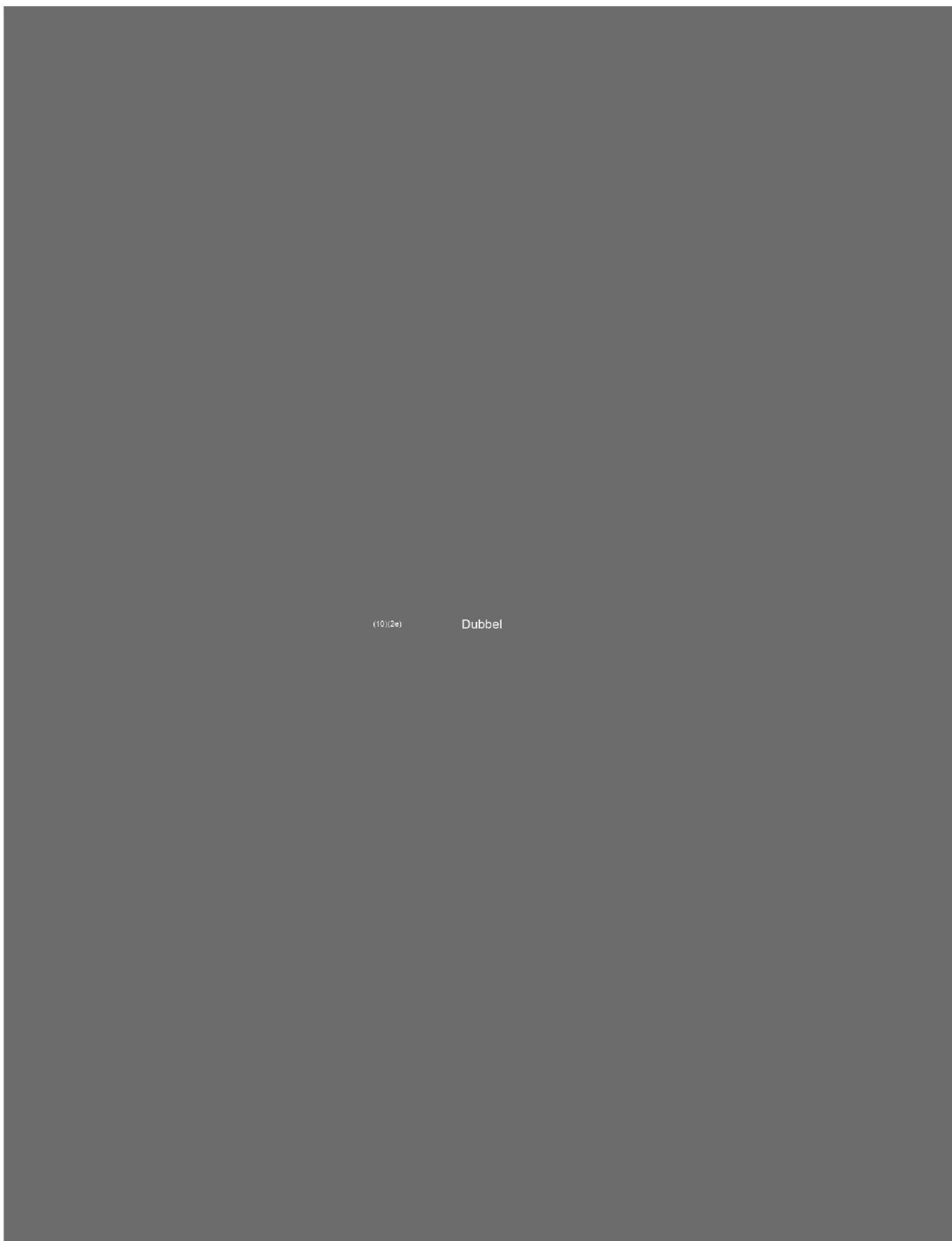
