Thank you for your availability in joining the meeting earlier today and for the useful exchange. As a brief summary, here are the main points that we discussed:

For tomorrow (pharmaceutical committee meeting)

- To refer to our joint non-paper, given that the Commission did not mention it in its summary of results of the roadmap consultation; nor on its discussion paper;
- To mention the political call expressed during informal health council of 16 July.

From now onwards

- To share among us – informally - input sent to the EU Commission, such as comments after pharmaceutical committee meeting; responses to the open consultations.
- In order to seek concrete solutions, we can start by identifying key topics for activity among our group. Ideally we could think of 6-7 measures with concrete actions and a possible deadline.
- Exchange via whatsappgroup: if you would like that, send us your mobile number and we will make a group.

Feel free to add points or share views. Please also find our response as submitted last Tuesday.

Last but not least, we also discussed that a follow up meeting mid October could be useful. Is there someone who would like to organize a next meeting?
