I hope that you have had an excellent summer and are ready and raring to go for the rest of 2020. With the 12th EIP Conference and 5th LifeCourse Immunisation Focus Group taking place in a little under 3 months' time (3-5 December 2020), I wanted to write to you regarding two points:

Please send me your 3 learning objectives and final title for your 2020 presentation/s by Friday 25th September. Something similar in style and format to the example from last year's meeting, below:

Session Title: Constipation in Infants and Children: Evaluation and Management

***(1) Understand** the epidemiology, definitions and clinical presentation of constipation*

***(2) Review** recent evidence-based guidance*

***(3) Consider** holistic treatment strategies involving both lifestyle and medication approaches*

Second, I would be most grateful to hear how you currently feel about travelling to Amsterdam later in the year for the annual conference in December and your view on how the COVID pandemic will evolve in the coming months.

As you know, in the interest of being fully prepared the Conference and Focus Group has been planned as a Hybrid meeting (online and onsite) since the beginning of April. The platform is ready and EIP has lots of experience in organising online sessions and meetings hosting over 60 webinars over the past couple of years.

The hope was that the pandemic would have been controlled by the end of 2020 and international travel and meetings would be back on. Unfortunately, infections are again on the rise in many European countries and across the world. The reality is that although delegates and speakers want to reconnect at live meetings, it may still be too early to host a truly successful event with a live/onsite element and that it should be only virtual this year.

The EIP team need to take the decision on whether to make the 2020 meeting fully virtual over the coming 15 days and your input and view are vital in helping us make the right decision.

Looking forward to hearing your thoughts and input on the above and to working with you on a hugely successful 2020 meeting.
