Good afternoon,

The air cargo chain has proven itself as solid during the COVID-19 crisis. Large quantities of protective equipment, medical devices and medicines were transported, despite the significant challenges faced by everyone. In the near future we face a new, or rather, additional challenge: the global logistics operation to distribute the COVID-19 vaccine around the world. We do not know yet when this operation will start and what the role of air freight will be. But what we do know is that it is important to prepare ourselves well for that moment and show the market that we are prepared and qualified.

KLM Cargo, Royal Schiphol Group and Air Cargo Netherlands recently conducted an initial exploration of opportunities, challenges and "things to do" with regard to the transport of the vaccine. Last week we discussed the first outcomes with a small group of experts. Now we would like to discuss the outcomes during an online meeting **on September 29th, 12.30 – 14.00 hours**. For this meeting we invite "all parties involved", including of course the members of the Pharma Gateway Amsterdam community, a number of pharmaceutical manufacturers and representatives of ministries. The aim is to position the air cargo chain in the Netherlands as preferred for the transport of COVID-19 vaccines.
