To protect your health and the health of the general public of Bonaire, you are required by the public health department of Bonaire to complete this form. This form allows the public health officers to use your information to contact you when necessary in case of issues with regard to COVID-19. It is important to fill out this form completely and accurately. Your information is intended to be held in accordance with applicable laws and is used for public health purposes only. Thank you for your assistance to protect your health and the health of the general public of Bonaire.

One form should be completed by each person. Parents should complete this form for minors.

Please complete this form between 72 and 48 hours before your departure to Bonaire.

Please print this form after completion and keep it in your hand luggage. You may be asked to show this during your journey by a public health officer.

To date Bonaire has been lucky not to have had a major long-lasting outbreak of COVID-19, primarily because we have implemented measures and have made it difficult for people from other countries to come to Bonaire. This was of vital importance for us. Bonaire is a small community and our health care has its limitations. Now that the borders have opened again we kindly but firmly request that you help us to keep coronavirus on Bonaire under control. Thank you for your cooperation. We wish you a pleasant and safe stay on our beautiful island.

Before you travel

You must undergo a PCR test within 72 hours of your arrival and the test result must be negative. If you cannot present a negative test result, you will be quarantined for 10 days upon arrival on the island. Additionally, you must complete a health declaration form for the Public Health Department and this must be done 48 to 72 hours before departure at: www.bonairepublichealth.org.

Please keep in mind that if you test negative before departure, this does not mean that you cannot contract coronavirus on the island.

If you have symptoms that could indicate COVID-19, such as:

- o Coughing
- o Shortness of breath
- o Runny nose
- o Loss of smell and/or taste
- o Fever (38 °C or higher)
- o Sore throat

Stay inside and call 0800 0800 even if the symptoms are very mild.

Always stick to the basic rules



Keep a minimum distance of 1.5 meters from others



Avoid crowds



Cough and sneeze into your elbow



Wash your hands regularly



Do not touch your eyes, nose or mouth

Registration and health check

Be aware that in certain locations you will be requested to register and complete a health check questionnaire.
