Dear Colleagues,

We were informed by our local authorities that 4 people tested positive after a shipping trip organised by a Dutch company. We have attached the letter explaining the situation. The positive test results were received on July 23rd and 24th. Information on contact persons - regardless of nationality - would need to be provided by the company. Please let us know if you need more information about the index cases and whether there were any more (10)(2a) contact persons on the fishing trip.

Thank you for this information. Could you provide us the date of onset symptoms from the 4 individuals? Were the 4 individuals family members or friends who stayed in the same cabin on the ship?

Dear colleagues,

We were informed that the deep-sea fishing outing took place from 17-18.07.2020 and the four cases feel ill within 3 days of the trip, so we would estimate the symptom onset to be 20-21.07.2020. We do not have the information concerning whether they stayed in the cabin or the nature of the contact. We were told that approximately 60 persons were said to be on board. More details would need to be requested from the shipping company located in the Netherlands. We would be grateful for any information on other (10)(2a) passengers that may have been on board that you could retrieve from the shipping company.

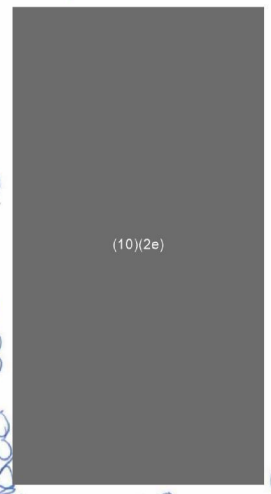
