



## AMENDMENT

This amendment is made to the September 1<sup>st</sup>, 2020 agreement previously executed by and between [State of the Netherlands], hereinafter called "[The Netherlands]" and AMI Expeditionary Healthcare, hereinafter called "contractor".

It is mutually understood and agreed by and between the undersigned contracting parties to amend that previously executed agreement as follows:

In Exhibit A #1 the following changes will be made:

- Change 1: 1 additional ER MD on Curacao (additional \$ 5.1.1c per week) – start date 10/1 (billed for October only)
- Change 2: 1 additional RT on Curacao (additional \$ 5.1.1c per week) – start date 10/4 – end date 11/10
- Change 3: 1 additional MD on Sint Maarten – no cost change
- Change 4: 1 additional RT on Sint Maarten – no cost change
- Change 5: Redaction: "Each team member will work 12-hours a day 7 days per week for six (6) months."
- Change 6: Redaction "to operate any vehicle or mobile equipment, or"
- Change 7: Change twenty-four staff members under Curacao to "thirty-nine"
- Change 8: Twenty under Curacao staff to say "Thirty-three"
