- Bij health care workers wordt itt 18-59 jarigen wordt dit dan juist wel weer sterker benoemd: *Prioritising healthcare workers for vaccination against COVID-19 becomes an effective and efficient approach to reduce COVID-19 overall morbidity and mortality if the vaccine quite effectively prevents infection and onward transmission.*
- Bij 18-59 jarigen vind ik sterk geformuleerd dat dit niet de strategie is die je (in eerste instantie) zal kiezen. Dit is gerelateerd aan wel/niet effect op transmissie maar lijkt mij ook context (nationaal) afhankelijk.

However, in general, other approaches should be prioritised in the context of initial limited supply or in case the COVID-19 vaccines showed very limited efficacy against SARS-CoV-2 infection and onward transmission.

En beperking dat grote leeftijdsgroepen zijn genomen (op zich logisch); bv weer 18-59 jarigen.

We are sharing with you, for your review ahead of the publication next week, the ECDC draft report “COVID-19 vaccination and prioritisation strategies”.

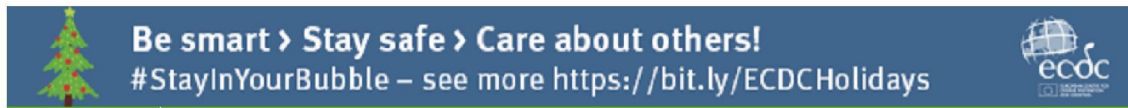
