Dear Members of the Steering Board,

The Ministry of Health Republic of Croatia welcomes the reservation of 300.000 doses of CureVac COVID-19 vaccine. We estimate the latter amount is justified given the number of inhabitants in Croatia and our previous reservations of vaccines from other manufacturers.

In regard to the additional order for CureVac vaccines, which purpose is primarily donation (resale is less likely), and with the aim to promote good neighborly relations, partnership approach and solidarity within the EU, we can confirm the reservation of an additional 100,000 doses, as we have previously expressed interest for.

More than the said 400.000 doses we believe we are not able to professionally justify, especially taking into account that Croatia has 4.2 million inhabitants.
