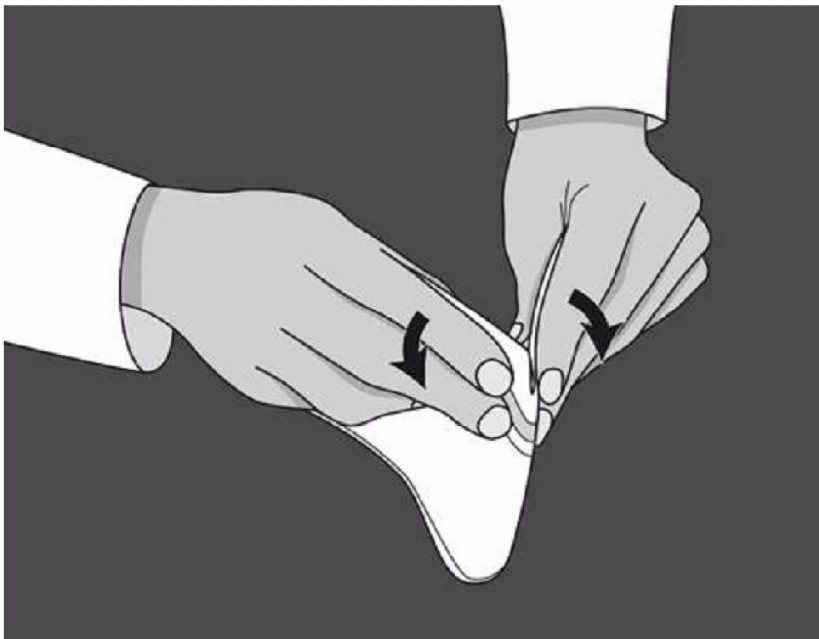

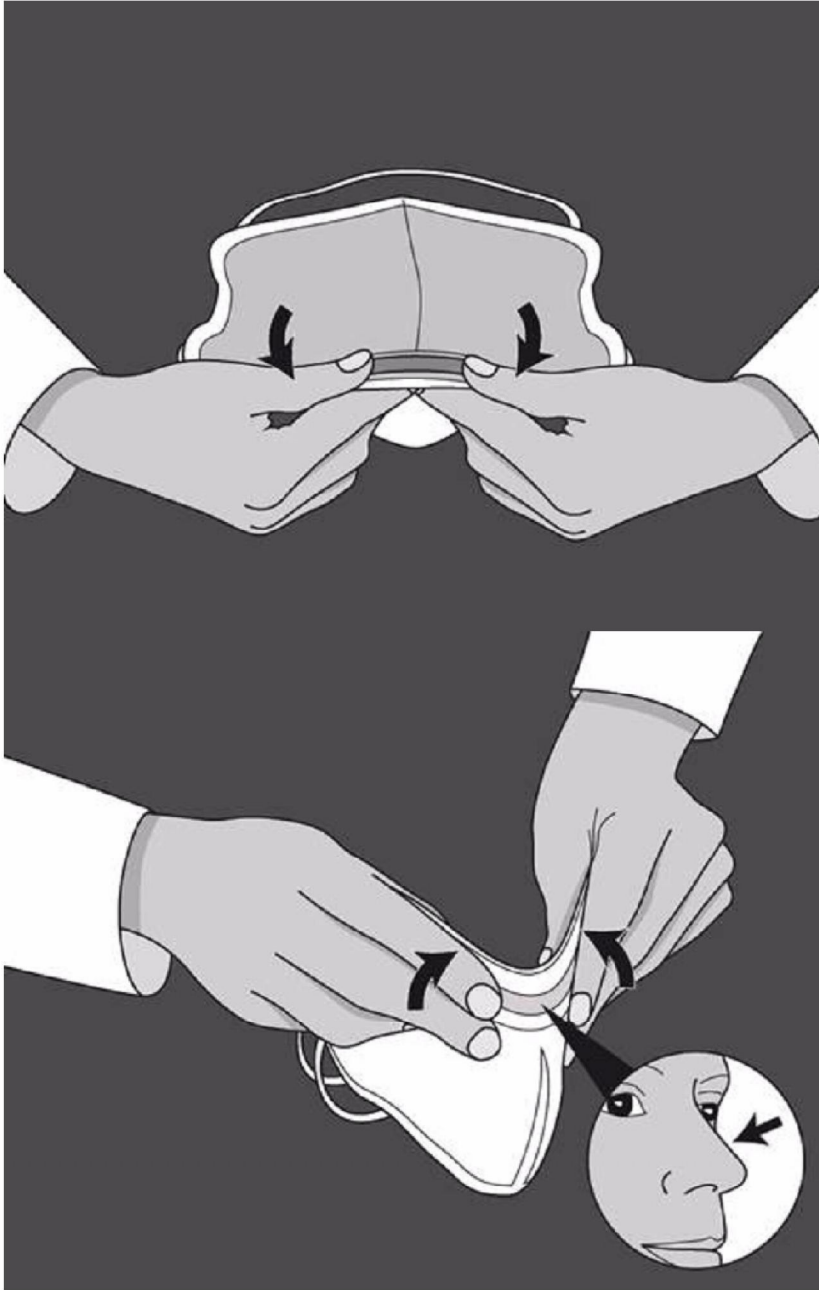
Thanks for your response. Hopefully we can receive the results soon. One remark regarding the instructions to put the mask on your face;

Thanks for your quick reply.

I am a bit astonished by the fact that the tests have not commenced yet. I attached an email which dates 25th of June as the day that our new samples for re-testing model TC-2-B1 have been send out to your facility, including the track and trace which states that 5.1.2e received those on the 29th of June.

After that, I was in the assumption that the re-test was already underway; see second email, which is discussing the fact whether our technical details for the re-tests were changed.

The third email shows that nothing was set on schedule yet, as I missed some kind of bureaucratic button for approval on the downside of the email. This while we were in communication on the retest of course (see mails before). Now I find myself, almost another month later to find out that BSI did not start the test. So from the moment of shipment of the second batch until today, almost 2 months in total have passed.

As you can imagine, I am very unhappy and dissatisfied with this course of events.

Could you see which person you can contact in your organization, is able to explain the situation and is able to compensate for this huge loss of time?

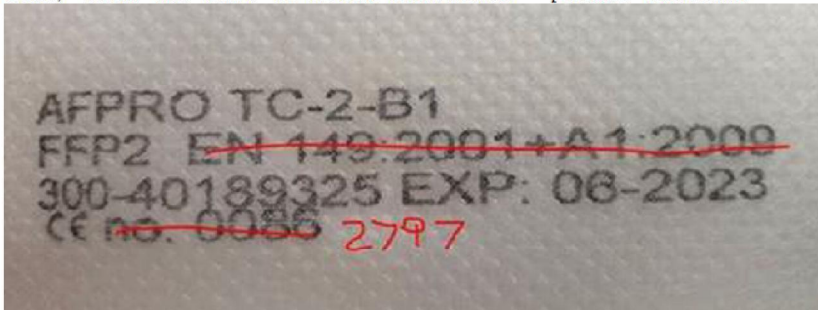
