Dear colleagues,

We have been requested by the Danish Ministry of Health to inform you about the Danish covid-19 passport. We are aware of the fact, that a negative covid-19 test is not a requirement for entry into the Netherlands. But we wanted to inform you of its existence.

The specimen of the official Danish "COVID-19 passport" can be accessed on the [www.coronasmitte.dk](http://www.coronasmitte.dk) web-page of the Danish police. (direct link: <https://politi.dk/-/media/mediefiler/corona/faktaark-teststrategi-og-smittesporing/covid19-pas--example.pdf?la=da&hash=16FA89ED772451326A6E64D363D4C9A9650D1783>)

There is free access to be tested for COVID-19 in Denmark, and the results are conveyed back to the individuals tested through the digital platform [www.sundhed.dk](http://www.sundhed.dk). Accessing the digital platform with a personal 'NemId' (a secure login), the individuals tested can download the COVID-19 passport only if the test result is negative, and the test is not more than 7 days old. Test results are by default documented digitally in Denmark and not with handwritten signatures.

Would you perhaps be so kind to send forward this information to other relevant Dutch authorities? Should you have any questions, please do not hesitate to contact us.
