Our lab is upside down with COVID!

We had a good result using Abbott Antigen tRapid Test and the results are pretty good indeed. WE have not discussed a national plan here [redacted] to include the Ag Rapid Test. We are planning to use it as a first test before doing RT-PCR in symptomatic patients. If Ag is negative we will do the RT-PCR. However, we think the Ag test can be used to test target populations such as Health Professionals weekly to make sure they are not carrying the viruses in Nasopharynge. We are evaluating the Ag test with a nasal Swab and the preliminary data is good. Maybe we will be able to use nasal Swab which I think will be more acceptable. Regarding the biosafety of the test itself I think the buffer contains Twen 20% and the virus is readily inactivated when mixed with the buffer.
