Good evening all,
 You are invited to attend the above mentioned meeting on **6 November 2020** from **13:00 to 18:00** Central European time.

An important discussion point is what methodological approaches can be used to generate critical evidence on COVID-19 vaccines (after interim results for vaccine 1 are available) and recommendations for deployment of an *unlicensed* vaccine are issued.

While use of placebo controls is most efficient and will provide the most timely, reliable, and interpretable results, a careful investigation of what data will still be needed (to inform policy and regulatory recommendations) on vaccine 1 is pertinent.

Equally important is to deliberate and issue recommendations on approaches to obtaining efficacy data when (and if) placebos can no longer be used.
