Hoi,

Hieronder is het meer "officiele" EWRS bericht van Denemarken over de nertsen en de nerst variant onder mensen naar alle EWRS landen. Het is eigenlijk nagenoeg hetzelfde bericht als wat Denemarken gisteren al had geantwoord op [REDACTED] 5.1.2e haar EWRS vraag.

Dear colleagues,

Denmark has since June 2020 experienced an extensive spread of SARS-CoV2 outbreaks in minkfarms. As of 3rd November a total of 197 farms are infected. Denmark is currently culling all infected minkfarms and also non-

infected minkfarms in a zone around these.

Statens Serum Institut has so far identified seven unique mink mutations/changes in the spike protein of the SARS-CoV-2 variants in mink, these variants have also been found in humans living in the affected areas. We have tested a variant with four simultaneous changes in the spike protein (Amino acid changes: 69del, Y453F, I692V, M1229I). This variant has been found in five minkfarms and also in humans in the surrounding community. A complete GISAID upload of all Danish Sars-CoV-2 sequences of human origin is planned for the end of week 45.

We have cultured this virus from a human patient and evaluated whether it was sensitive to neutralizing antibodies (antisera) from a collection of sera from convalescent COVID-19 patients. We found that this virus showed less sensitivity (resistance) for neutralizing antibodies from persons with previous COVID-19 infection. These results are preliminary and are in the process of being confirmed in an independent repeat experiment. However, the finding suggests that mink-specific mutations potentially can influence virus' sensitivity to protective antibodies after an infection with a non-mink variant of SARS-CoV-2. This may also pose a threat in terms of effectiveness of spike protein directed COVID-19 vaccines on specific mink variants of SARS-CoV2.
