First allow me to thank you all for the significant efforts to respond to the survey circulated on the 20 October following a request from the European Commission. Please find a summary of all the responses in attachment. The information has been presented to the Health Security Committee and has been shared with the Cabinet responsible for the advance purchase agreements.

We have since the EC Communication on [October 15](#) when the Commissioner mentioned that an overview of vaccination deployment plans was being compiled received several requests for information from media wishing to be informed about the vaccination preparedness plans in the EU. We therefore wish to publish this document on the ECDC website after your validation. We understand the developments are happening rapidly also moving forward but the information in this report is expected to be accurate on November 19, 2020.

We are therefore now kindly asking you to review the attached "Overview of current EU/EEA and UK deployment and vaccination plans for COVID-19 vaccines dated 19 November" and make sure that we are accurately describing your vaccination plans as they are now. We are all aware of that plans may/will change moving forward given all the uncertainties in particular both on the short-term and long-term safety and efficacy of the coming vaccines since all information we have so far is confined to press releases from two vaccine producers.

We highly appreciate your time and effort for checking that information on your country is correct in **text and tables**. Please respond to this e-mail that information is correct if it is or if you wish to suggest edits please do by returning an edited report. After confirming content is correct we would also appreciate that should there be updates in the different areas of the survey relevant up to 19 November, please also add information on such updates in the attached document and return it to us.
