The issue of the letter was clarified at sherpa level. All other Member States have nominated a top expert advising the Head of State or Government. The first meeting was organised last Friday (see press release https://ec.europa.eu/commission/presscorner/detail/en/IP_20_2125) and the next one will be this Friday.

From then on, it will be organised every two weeks (3/12, then 17/12). The videoconference lasts 1h15 and is chaired by Commissioner Kyriakides with support from [redacted] 5.1.2e. It is a chance for experts to discuss and share experiences while gradually moving towards common analyses and recommendations (e.g. where to use antigen tests, how to handle quarantines, how to get ready for the vaccines roll out, etc.).

The Dutch expert is of course more than welcome to join the second session this Friday, and you can send his/her name to us to include for the Friday meeting.

Emne: Science Adviser Platform

Dear colleagues,

During yesterday evening's videoconference of the members of the European Council, President von der Leyen announced the establishment of an EU scientific advice platform on COVID-19. As discussed by the Leaders, this platform will bring together scientists advising Member State governments and the Commission at the highest level. Its purpose will be to facilitate better, faster and more co-ordinated scientific advice to inform COVID-19 policy responses in public health, essential to contain the spread of the virus.

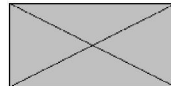
Commissioner Kyriakides will write to Member State health ministers shortly and request their nomination of members of the platform, who should be science advisors on COVID-19 to Member State governments, by *Friday 6 November*. The platform and its members are also expected to have a public facing role in order to enhance communication on, and compliance with, COVID-19 measures. Nominees should therefore be experienced in communicating with the broader public.

The Platform will be chaired by the Commission with support from the European Centre for Disease Prevention and Control (ECDC) and 5.1.2e President von der Leyen's special advisor on COVID-19. Further details on the agenda and date of the first meeting will be shared shortly.
