Dear Health Security Committee, Joint Procurement Agreement Steering Committee,

As a follow up to earlier emails, please see below for update on the last 3rd instalment of 4 million PPE masks, procured through the Emergency Support Instrument.

[5.1.2a] As before and due to the quality issues which arose previously, we have tested the instalment of the KN95 masks in China prior to transport into the EU. [5.1.2a]

[5.1.2a] Please find attached the test results.

Arrangements for transport of the masks to countries have already started and the estimated first arrivals are scheduled as from Thursday, 27 August. The transporter will be in touch shortly with the given contact points to arrange logistical details.
