Overall solution


Purefic solution bundle use electrolyzed water (EW) as sanitization solution for purifying close spaces. We provide a complete solution from producing the solution in small or industrial capacities and varied product line for application from small to large spaces. We offer customizable sanitization programs that are tailor-made for any need.

HOCL is a natural substance our body produces as a first line of defence against pathogens. It is extremely safe, bio- degradable and non-corrosive. It is nonflammable and chemical free. This material was proven to be effective not just against the Corona virus but also against harmful pathogens like MRSA, positive and negative gram bacteria in 99.999999% efficacy (log8 reduction).

EW Production Unit:

A Purefic solution has highly effective protective properties against an array of pathogens. The solution undergoes electrolysis in special electro-chemical cells in which the pH of the water is manipulated to be in a well-defined range. The active material is Hypochlorous acid (HOCl) in a concentration range of 50-200 ppm and a pH range between 4.5 and 6.5.

The system has the capability to choose the pH and active material concentration.


Our line of tunnels can fit any use and traffic capacity.

Machine Devices and Parts

The machine is set to work in a humid environment. All the product contact parts are stainless steel. The machine is constructed of stainless steel, anodized aluminum and plastic, all of which conform to CE, UL, 3A, FDA Grade A standards. All required approvals from local safety and standards agencies are the responsibility of the Buyer. Purefic agrees to meet recommendations made by these agencies.

Safety

Purefic Equipment is designed to comply with Safety Standards to the best of our abilities and interpretation. Full compliance with local Safety Standards involves the use of the equipment at the customer's location and therefore is not fully controllable by the manufacturer. We cannot, therefore, certify that our equipment conforms in all respects with your local Safety Standards. Upon Buyer's inspection and testing at Seller's location, any specific requirements of Buyer to address regulations requiring additional work by Seller will be quoted by Seller. Seller does not represent or warrant that equipment sold by it complies with any like state / provincial or local law or regulation, and the cost of modifications and responsibility for compliance are the Buyer's responsibility.

Documentation

Operation and maintenance manuals are included with the machine in both hard copy and digital formats.

Terms and Conditions Of Sale

These Terms and Conditions of Sale shall cover the product sold by Purefic. to the original buyer ("Buyer") as described in the product's purchase order, manuals, and other attached documentation ("Product"). Buyer hereby acknowledges and agrees to the following Terms and Conditions of Sale:

Pricing

All prices, terms, discounts, and specifications are subject to change with 60-day notice. Unless otherwise agreed upon in writing signed by Purefic and the Buyer, orders will be billed at the prices in effect at the time of accepted order. Prices are exclusive of federal, State/Province, or local taxes of any nature. The Buyer shall pay all taxes applicable to Products ordered. If Buyer is exempt from any kind of tax, Buyer shall provide Purefic. with a tax exemption certificate acceptable to taxing authorities. In the absence of a tax exemption certificate, taxes will be charged and payable until a valid tax exemption certificate is on file.

Payment Terms

Unless otherwise expressly agreed to in the purchase order, payment terms to Buyer are cash before delivery. Past due or otherwise delinquent account balances, or any part thereof, are subject to a service charge equaling the lesser of 1.50% per month until paid or the

legal maximum allowable in the Buyer's State/Province. Past due or otherwise delinquent account balances may, at the sole option of Purefic be placed for collection. The Buyer hereby agrees to pay all expenses incurred including but not limited to collection fees, court costs, and reasonable attorney fees. In the event any of Buyer's payments are not promptly made when due, Buyer shall be in default of these Terms and Conditions of Sale and all unpaid amounts shall immediately become due and payable. In the event Buyer's account is past due or otherwise delinquent, the Buyer agrees that Purefic may offset the account balance, or any portion thereof, against any funds of the Buyer held by Purefic.

Warranties and Limitation On Liability

Purefic warrants all Products to be free from defects in material and workmanship for a term established by the specific warranty included with a Purefic Product (the "Product Warranty"). The obligations of Purefic under the Product Warranty shall be limited to the repair or exchange or giving credit for, at the option of Purefic, any Products which may thus prove defective in accordance with evidence satisfactory to Purefic. Any repair or replacement of Products by Purefic shall not extend the original Product Warranty period. In the event a warranty is not included with the Purefic Product, the warranty set forth in these Terms and Conditions of Sale shall be the Product Warranty and the term of such Product Warranty shall be twelve months from the date of shipment from Purefic to Buyer. The Product Warranty shall not apply to any Products that have been subject to accident, negligence, unauthorized alteration or repair, abuse of misuse, or unusual stress. Purefic expressly disclaims all other warranties, including but not limited to any warranties of merchantability or fitness for a particular purpose. Purefic Shall in no event be liable for any special, indirect, incidental, consequential or punitive damages or for loss, damage, or expense, including loss of use, profits, revenue, or goodwill, directly or indirectly arising from buyer's use or inability to use the products, or for loss or destruction of other property or from any other cause, even if Purefic Has been advised of the possibility of such damage. The liability of Purefic shall in no event exceed an amount equivalent to the purchase price paid by the buyer.

Buyer's Purchase Order; Acceptance Of Orders; Conflict Of Terms

All purchase orders are subject to acceptance by Purefic in its sole discretion. No sales are final until accepted in writing by Purefic. In the event the Buyer shall submit a purchase order, the written terms of which are in conflict with these Terms and Conditions of Sale, these Terms and Conditions of Sale stated herein shall prevail. Any attempt to modify these Terms and Conditions of Sale or subject Purefic to additional terms and conditions shall be null and void, unless Purefic and the Buyer shall have first entered into a signed agreement making such modifications or imposing such additional terms and conditions. A purchase order placed by Buyer and accepted by Purefic shall not be cancelled thereafter by Buyer without Purefic's written consent, and such consent may require indemnification for any loss suffered by Purefic. Shipments will be made upon Purefic's acceptance of Buyer's order. Acceptance includes approval of credit in accordance with Purefic's customary terms.

Delivery

Products are shipped pursuant to the Product's purchase order. Purefic shall not be responsible for shipping delays caused, directly or indirectly, by circumstances which are beyond its control. Risk of loss due to damage, shortage or non-delivery due to carrier fault lies with the Buyer. The Buyer should make all claims for damage or shortages to carrier immediately upon receipt of material. Any claims stemming from discrepancies between the invoiced descriptions or quantities and the actual Product received by the Buyer alleged to be due to error by Purefic must be made in writing within thirty 30 days of the invoice date. Any such claim not presented within the time specified will be waived and actual delivery of invoice descriptions or quantities will be deemed accurate. Any default by the Buyer of these Terms and Conditions, including but not limited to, failure to make timely payment on any order of Products or failure to make timely payment for any amounts due by the Buyer to Purefic, shall also constitute a basis for cancellation or postponement of delivery by Purefic of any order placed by Buyer even if such order has already been approved by Purefic.

Title Assignment

Although title and risk of loss passes to Buyer at point of shipment, the Buyer hereby grants Purefic a lien to secure payment, regardless of physical location of the goods. Said lien survives until payment in full has been received by Purefic

Product Installation And Operation

Installation of Products shall only be performed by Purefic or its agents. Buyer assumes all responsibility for the proper operation and maintenance of the Products purchased from Purefic shall not be responsible or liable in any way, in whole or in part, for any damages, including, but not limited to, any special, incidental, consequential or punitive damages arising from any claim or theory whatsoever, except as specifically set forth in the Limited Warranty clause in paragraph 3 hereof.

Authority Of Buyer's Personnel

Purefic is entitled to rely upon the apparent authority of all of Buyer's employees and agents who place orders for or on behalf of Buyer.

Severability; Modification And Waiver; Assignment

In the event that any provision of these Terms and Conditions is found to be unenforceable in any legal proceeding, the remaining provisions shall remain in full force and effect. No modification or waiver of the terms contained herein shall be effective unless authorized in writing signed by a duly authorized officer of Purefic and Buyer. No course of dealing between the parties or any failure or delay on the part of Purefic in exercising any rights or remedies, and no single or partial exercise of any rights or remedies hereunder, shall operate as a waiver or preclude the exercise of any other rights or remedies hereunder. Buyer's rights hereunder cannot be assigned nor can the performance of its obligations be delegated without the prior written consent of Purefic

Notices; Change Of Buyer's Name Or Address; Reorganization

All notices permitted or required pursuant to these Terms and Conditions shall be sent by registered or certified mail, addressed to the parties at their principal offices until notice of a change of address or contact person is given to the party. Such written notice shall be effective as of the third business day from the date of posting. Buyer hereby agrees to immediately notify Purefic in writing of any changes of name or address, or of any corporate reorganization or change of ownership regardless of whether it results in a change of name or location of the Buyer.

Governing Law; Consent To Jurisdiction

These Terms and Conditions of Sale shall be governed by and construed in accordance with the laws of the United Kingdom. Buyer hereby irrevocably consents to exclusive jurisdiction in courts of the United Kingdom and of any federal courts located in the United Kingdom. Notwithstanding the above, in the event of a dispute regarding non-payment, Purefic shall have the right in its sole discretion to pursue legal action against Buyer in any court of competent jurisdiction, including, without limitation, any federal or state court located in a different state. In the event Purefic institutes any legal proceeding against Buyer including a proceeding to collect any amount due by Buyer hereunder, Buyer shall be liable to Purefic for all legal fees and costs as well as collection costs and expenses (including reasonable attorney's fees for such collection) incurred in connection therewith. The parties expressly waive trial by jury and waive any right to object on the basis of inconvenient forum or venue in all the above jurisdictions.
