Dear Netherlands IHR NFP,

The Singapore Ministry of Health would like to notify you of close in-flight contacts associated with a COVID-19 case with travel history to New Zealand, Singapore and Japan.

The case had travelled from New Zealand to Singapore via [REDACTED] 5.1.2e on 8 August 2020, and from Singapore to Japan via [REDACTED] 5.1.2e on 9 August. The case was asymptomatic and had subsequently tested positive in Japan on 9 August 2020.

As part of our contact tracing efforts, we have identified close in-flight contacts onboard the [REDACTED] 5.1.2e flight who are citizens of your country. These contacts have left Singapore and we do not have information on whether they have returned to the Netherlands.

Details of the contacts are enclosed in the attached password-protected document for your information and follow-up if deemed necessary please. The password will be shared with you in the subsequent email.
