Thank you for this information. The Public Entity of St. Eustatius is pleased with the decision to have the elective care take place in Aruba, Curacao & Bonaire. Please give some much needed attention to how the care for the dialysis patients will be managed during the hurricane season in combination with the COVID 19 pandemic. Drawing from our experience with hurricanes and their impact on St. Maarten/St. Martin in 2017 it is not advisable to have Stata/Saba dialysis patients there during the peak.
