Hierbij het actualiteitenbeeld van Sport voor het BTC van 20 oktober:

- De nieuwe maatregelen in de sportsector zijn over het algemeen goed geland en worden goed opgevolgd. NOC*NSF heeft zijn protocollen hierop aangepast en heeft zijn bonden goed geïnformeerd. Er komen nog wel veel praktische vragen van bonden hoe e.e.a. in te regelen.
- Er is in de sportsector onduidelijkheid over de uitzondering die gemaakt is voor de cultuursector en de vraag waarom er niet één lijn getrokken is met de sportsector.
- In de topsport is onrust over het vrouwenvoetbal. Het besluit van het kabinet om de uitzondering van de BVO's in het betaalde voetbal uit te breiden naar eredivisieclubs van het vrouwenvoetbal, heeft geleid tot onbegrip binnen de sportsector. Men verwacht dat deze uitzondering nu ook komt voor de topcompetities in andere takken van sport.
