Dear [REDACTED] and colleagues,

Many thanks for your email and sincere apologies for the errors. We made some last minute changes in the metadata which were not reflected in the template and we missed some of the "standard" TESSy variables.

To answer your questions:

1. Indeed there are differences in the two documents. The most important document however is the TESSy metadataset (always available in TESSy: <https://tessy.ecdc.europa.eu/TessyHelp/index.aspx?navigation=TechnicalGuidelines>) – follow the coding there and you will be correct. We have now corrected the template (see attached). Regarding the variable datasource, one has been created for each country. The one for NL should be NL-NCOVVACC.
2. The GeneralComment field has just been added in TESSy. You should be able to use it now. There is no need to repeat the comment in every record, once is enough. If there is a change in future weeks then please update the comment.
3. This issue should now be fixed.
4. I would suggest that you either report three records as you describe below or alternatively two ("ALL" and "HCW"). If you eventually obtain a breakdown by age group, then you can report the data also by age group.

Again, our apologies for the teething troubles and many thanks for your comments and efforts. Please let us know if you find any other issues!

Dear colleague,

We have received your data call in good order. When preparing our first dataset we came across some questions and remarks (see also added Excel-file):

1. There are some differences between what is stated in the Reporting Protocol and what is shown in the template file, which of them is leading?

2. Because of these differences we decided to upload the data to Tessy 'Manually create a record' but in that case we were not able to add a general comment as this field is not included. Please advise how we can add this comment to our data:

**DATA NOT COMPLETE:** In the first 2 weeks of January acute care HCW in hospitals and HCW in LTCF were vaccinated with Comirnaty. At this moment, we have only data for the acute care HCW in hospitals and not for HCW in LTCF. The data for acute care HCW in hospitals concern estimates based on news items of the National Network Acute Care (<https://www.inaz.nl/actueel>).

And should such a comment normally be added for every record?

3. Furthermore, we were not yet able to upload the preliminary data for week 2 as it concerns a 'reporting period with End Date in the future'. Please advise on how to proceed with this.

4. Finally, we were not sure if we needed to add 3 records (ALL, HCW, AgeUnk) per week for our situation or if only 1 record (ALL) per week would have been sufficient as our data at this moment only concerns 1 group of HCW with unknown age. We have now decided to add 3 records but please let us know if you prefer 3 or 1 record for the future.

Thank you in advance for your response and good luck with the data collection!
