



Round Table Report 2 November 2020

For restricted use

This report summarizes the ECDC daily roundtable discussion and provides update on threats detected and monitored by Epidemic Intelligence.

Active threat

COVID-19 associated with SARS-CoV-2 - multi-country (world) - 2020

Sources: This update is based on multiple official sources, including <u>WHO updates</u>, Ministries of Health, National Health authorities and official social media accounts. Detailed updates are presented on the <u>ECDC website</u> and <u>ECDC COVID-19 dashboard</u>.

Update: Since the previous RT report published on 01 November 2020 and as of 02 November 2020, 428 184 new cases of COVID-19 (in accordance with the applied case definitions and testing strategies in the affected countries) and 4 795 new deaths have been reported.

New cases have been reported from Europe (213 474), America (122 885), Asia (82 239), Africa (9 573) and Oceania (13). The five countries reporting most new cases are: United States (81 001), France (49 290), India (45 231), Italy (29 905) and United Kingdom (23 254).

New deaths have been reported from Europe (1 802), Asia (1 357), America (1 326) and Africa (310). The five countries reporting most new deaths are: India (496), United States (440), Iran (434), Russia (245) and France (231).

Summary: Since 31 December 2019 and as of 02 November 2020, 46 597 299 cases of COVID-19 (in accordance with the applied case definitions and testing strategies in the affected countries) have been reported, including 1 201 162 deaths.

Cases have been reported from:

Africa: 1 796 748 cases; the five countries reporting most cases are South Africa (726 823), Morocco (222 544), Egypt (107 736), Ethiopia (96 583) and Nigeria (62 964).

Asia: 13 626 009 cases; the five countries reporting most cases are India (8 229 313), Iran (620 491), Iraq (475 288), Indonesia (412 784) and Bangladesh (409 252).

America: 20 807 415 cases; the five countries reporting most cases are United States (9 207 362), Brazil (5 545 705), Argentina (1 173 520), Colombia (1 083 321) and Mexico (929 392).

Europe: 10 324 515 cases; the five countries reporting most cases are Russia (1 636 781), France (1 413 915), Spain (1 185 678), United Kingdom (1 034 914) and Italy (709 335).

Oceania: 41 916 cases; the five countries reporting most cases are Australia (27 595), French Polynesia (7 262), Guam (4 693), New Zealand (1 607) and Papua New Guinea (590).

Other: 696 cases have been reported from an international conveyance in Japan.

Deaths have been reported from:

Africa: 43 202 deaths; the five countries reporting most deaths are South Africa (19 411), Egypt (6 278), Morocco (3 762), Algeria (1 973) and Ethiopia (1 478).

Asia: 242 363 deaths; the five countries reporting most deaths are India (122 607), Iran (35 298), Indonesia (13 943), Iraq (10 966) and Turkey (10 326).

America: 644 220 deaths; the five countries reporting most deaths are United States (230 996), Brazil (160 074), Mexico (91 895), Peru (34 529) and Colombia (31 515).

Europe: 270 319 deaths; the five countries reporting most deaths are United Kingdom (46 717), Italy (38 826), France (37 019), Spain (35 878) and Russia (28 235).

Oceania: 1 051 deaths; the five countries reporting most deaths are Australia (907), Guam (79), French Polynesia (29), New Zealand (25) and Papua New Guinea (7).

Other: 7 deaths have been reported from an international conveyance in Japan.

EU/EEA and the UK:

As of 02 November 2020, 7 569 075 cases have been reported in the EU/EEA and the UK: France (1 413 915), Spain (1 185 678), United Kingdom (1 034 914), Italy (709 335), Germany (545 027), Belgium (440 923), Poland (379 902), Netherlands (359 437), Czechia (341 644), Romania (246 663), Portugal (144 341), Sweden (124 355), Austria (111 110), Hungary (82 780), Ireland (62 002), Slovakia (59 946), Bulgaria (54 069), Croatia (51 495), Denmark (47 299), Greece (40 929), Slovenia (35 649), Norway (19 563), Luxembourg (18 782), Finland (16 291), Lithuania (15 719), Malta (6 182), Latvia (6 136), Estonia (4 985), Iceland (4 890), Cyprus (4 563) and Liechtenstein (551).

As of 02 November 2020, 222 701 deaths have been reported in the EU/EEA and the UK: United Kingdom (46 717), Italy (38 826), France (37 019), Spain (35 878), Belgium (11 737), Germany (10 530), Netherlands (7 424), Romania (7 067), Sweden (5 938), Poland (5 783), Czechia (3 429), Portugal (2 544), Ireland (1 915), Hungary (1 889), Bulgaria (1 298), Austria (1 114), Denmark (723), Greece (635), Croatia (562), Finland (358), Norway (282), Slovenia (236), Slovakia (219), Lithuania (166), Luxembourg (160), Latvia (74), Estonia (73), Malta (64), Cyprus (26), Iceland (12) and Liechtenstein (3).

EU:

As of 02 November 2020, 6 509 157 cases and 175 687 deaths have been reported in the EU.

Public Health Emergency of International Concern (PHEIC):

On 30 January 2020, the World Health Organization declared that the outbreak of COVID-19 constitutes a PHEIC. On 11 March 2020, the Director-General of the <u>WHO</u> declared the COVID-19 outbreak a pandemic. The <u>third</u>, <u>fourth</u> and <u>fifth</u> International Health Regulations (IHR) Emergency Committee meeting for COVID-19 were held in Geneva on 30 April, 31 July and 29 October 2020, respectively. The committee concluded during these meetings that the COVID-19 pandemic continues to constitute a PHEIC.
