Thank you for contacting us with your request. Entry to Saba is possible. In order to do so you will need a travel exemption letter which outlines the requirements pre-travel and upon arrival to the island, which must be adhered to. I have attached two files that are required for you to fill in and send back to us, within 14 days of your arrival to Saba.

Below is further information concerning entry requirements:

1. Fill in Entry Application Form

This form contains questions that should be answered with accurate information. This form will also specify the countries that range from low to high risk so you know which category you fall into. Please fill in the information directly in the word document itself, typed out. If this is not possible, you can print out the form, fill it in and then scan it back to us.

2. Waiver

This must be signed and sent back along with your entry application form.

Once we receive the form and the signed waiver from you, we will process your travel exemption letter. All exemption letters must be issued within a 2-week time frame prior to your arrival, as a requirement from Immigration on island. We therefore encourage persons to email us this information 2- weeks prior to their confirmed arrival date.

Please note the following information below.

Travel categories-Testing and Quarantine

- 1. If you are traveling from a <u>low-risk</u> area, Saba does not require testing or quarantine, but you are still required to have the travel exemption letter to enter the island.
- 2. If you are traveling from a <u>medium-risk</u> area, Saba does not require that you be tested, however you must quarantine for 10 days upon arrival at your own cost. Please note that although Saba does not require testing from medium-risk areas, if traveling through St. Maarten you must follow their entry requirements which may include testing.

3. If you are traveling from a <u>high-risk area</u>, you are required to have a negative COVID-19 PCR result, quarantine for 10 days at your own cost and be tested at the end of quarantine on Saba.

All COVID-19 PCR tests must be taken as follows:

- taken 72 hours maximum before arrival, if traveling from within the Caribbean Region
- taken 120 hours maximum before arrival, if traveling from Europe, North, Central and South America, Canada, and Asia.
- If traveling from low- medium or high-risk areas through St. Maarten you must also follow their entry requirements which may include prior testing. Each island/country has different requirements for entry. Click on the link for more information regarding entry to St. Maarten. this: https://stmaartenehas.com/travel-requirements/
 - 5. All persons traveling to Saba must have travel insurance that provides coverage for COVID-19, hospitals, and medivac circumstances and you must be content with the level of cover it provides.
 - 6. Incoming passengers are allowed to quarantine in their own homes, apartments or hotel following strict guidelines, which are outlined in the quarantine waiver attached. You are responsible for your own food and supply arrangements while in quarantine, or this may be included in your accommodation package. Arrangements can be made by contacting the local supermarkets for food delivery, or restaurants for food arrangements.

**There are currently only scheduled flights between St. Maarten and Saba on Fridays and Saturdays. If you wish to travel
on a different date, you will have to charter a flight or remain in St. Maarten until the next available flight. There are
currently no ferry services to the island.
