Dear delegates,

On behalf of the Commission, please find attached the latest *Overview of measures taken by Member States on lifting of internal border controls and lifting of restrictions to free movement within the EU*, as well as the *Overview on Member States' follow-up on the Council Recommendation on the temporary restriction on non-essential travel into the EU and the possible lifting of such restriction*, dated 26 January 2020.

The attached tables include updates from **AT, CY, CZ, EE, FI, FR, IS, IE, LV, NO, PL, RO and CH**.

With reference to Annex I of Council Recommendation 2020/912 of 30 June 2020 on the restriction on non-essential travel into the EU, some Member States have yet to provide information as to whether they have reintroduced the restrictions for Canada, Tunisia, Georgia and Uruguay, and whether they have lifted the restrictions for Singapore, Macao and Hong Kong. To this end, delegations are kindly requested to inform the Commission on whether they have taken the necessary national decisions to align to the amended Annex I.

If possible, the Commission would be grateful if, when sending their updates, delegates could send only the parts concerning their Member State or Schengen Associated Country.
