 We would like to kindly remind you to return to us as a matter of urgency the following documents:

1. Completed Subcontractor Engagement Letter; and
2. Copy of the Wholesale Distribution Authorisation of your receiving warehouse.

As you will be aware there is significant sensitivity about the confidentiality and security of the supply chain arrangements for delivery of the vaccine, and in this regard, we would need item (2) returned before engaging directly in discussions with your subcontractors. In the event that we do not have this item returned prior to your country call, we will unfortunately not be able to engage with your subcontractor and will need to ask them to leave the all which would unfortunately result in delays. Therefore we appreciate you treating this item as a matter of priority today.
