Delivery timing assumptions

As of January 3, 2021

This Estimated Delivery Schedule is contingent upon the following:

European Commission Marketing Authorisation is granted on or before January 9, 2021. If Marketing Authorisation is granted later, shipment timing will shift accordingly.
Product will be packaged using Moderna Pandemic Packaging in English language, with the same pack supplied across all Member States.
Moderna will make digital versions available of the SmPC, Patient Leaflet, and Patient Information Card in local languages. These will be found on Moderna's central website (https://www.ModernaCovid19Global.com) for download and printing by local distributors. This website will be easily accessible via a QR code printed on every individual package. Printed material will not be provided by Moderna before March 1, 2021.
Moderna conducts its supply and distribution and operations in a single harmonised manner in accordance with EU law, as described in a Moderna communication to the Commission dated December 29, 2020, specifying the uniform approach that Moderna will be able to provide as of January 2021 for (1) Distribution Model, (2) Licenses and Authorisations, (3) Quality / Product Release, (4) Pharmacovigilance, and (5) Scientific Service and Other Local Representatives.
