I wanted to reach out to talk to you about the work we are currently doing with British NHS Trusts in supporting the roll out of the vaccine here in the UK and how this can be replicated for the Dutch vaccinatieprogramma.

Using our digital workforce, we can speed up the documentation process for the vaccine roll-out and save 7-10 FTEs worth of work each day, per NHS Trust (Similar to GGDs).

Additionally, this can also be documented to provide a clear record of what inoculation was given, on what date, and to whom, so that a clear paper trail can be documented, and the necessary reports created.

This process is completed with 100% accuracy, with complete transparency and nonrepudiation, 24/7, and has no human-error. Resultantly, healthcare officials are not limited by administrative burdens and capacity for the vaccine rollout is increased.
