Thank you very much for your reply.

In my view the new figures for the population over 60 sounds more realistic. Same for the undocumented. So in total for people over 60 incl undocumented: 16.788.

In order to answer your second question I would like to refer to your vaccination implementation initial plan with the tables. This is really very well presented in the tables on page 17.

Healthcare professionals, working or in direct contact with highest risk groups (groups 2-4)

- 1a White and yellow cross foundation
- 1b SMMC
- 1c Mental health foundation

- 1d CPS
- 1e Turning point
- 1f GPs
- 1g Ambulance

In total 767

All other healthcare professionals working or in direct contact with patients and those who cannot social distance (community health workers, mortuary services)

- 8a SMMC (rest)
- 8c Laboratories
- 8d Pharmacies
- 8e Dentists and assistants

In total 288

This makes a grand total of 16.788 (60+) and 1.055 = 17.843

Of course in reality you will not vaccinate 100% of the elderly, in other words you will have more vaccines to use for the medical staff.

Conclusion: from my perspective 17.843 is a considerable amount of requested vaccine.

As you all know, I am not the one who decides the destruction of vaccines. That's up to the political level.

The estimated population numbers of December 17, 2020 were based on the official and publicly available population numbers from 2017. Since then, we have received updated yet unpublished population numbers from civil registry. They provided us with the new number of 13,008 people of 60+ years, constituting 21% of the total population.

In addition, there are an estimated 18,000 undocumented people on Sint Maarten. We estimate that 21% of them are 60+, thus 3,780 people. The estimated total number of people of 60+ years of age thus is: 16,788.

Sint Maarten would like to request the first batch of vaccines to be made available to this group.

With regard to the other group that is eligible for the first batch of vaccines, would you please be able to provide some clarity on the specific groups to be included? Sint Maarten would like to include healthcare staff of the hospital, the ambulance service, first responders, elderly homes, (mental) disability homes, long-term care facilities, CPS and GPs, as well as patients of elderly homes, (mental) disability homes, district nursing and long-term care facilities .

Subject: Number of vaccine for first trance / delivery

Dear [REDACTED]

As promised I would like to come back to the issue of the number of vaccines.

As you know the Minister of Health has decided that for the first trance, vaccines are available for all 60+ and medical critical staff. We have received a document with the breakdown of the requested number of vaccines dated 17 December. In that document you classify the group of 60+ as the so called 2A. You have estimated that this group is 6000, which is 15% of the total population. This number has been used by the Minister to inform the parliament of what is needed for the islands. However, in the document of 11 January you have mentioned a new estimate of 13008 for the 60+ population. It would be very helpful you could provide the background of this increase. I will provide this new number to the RIVM and your wish to include this in the first trance. Of course I don't know the amount of vaccines available and I don't decide on that.
